# **Annual Report for 2022-2023**

# **SWCS Goes to Washington (DC)**

This past Spring, SWCS CEO Clare Lindahl spent eight weeks living and working in Washington, DC, taking the voices of conservation professionals to the desks of leadership, building collaborations to advance member issues, and bringing back happenings on Capitol Hill to inform those advancing conservation locally.



During her visit, Lindahl gathered information to better define how SWCS can play an effective role in advocacy and policy. In this vein, starting in July, Rachel Owen was brought on as SWCS's senior advisor to consult on advancing recommendations from Lindahl around advocacy and other organization growth.

Additionally, Lindahl worked closely

with the SWCS National Capital Chapter located in Washington, DC, to plan and host three networking socials and one service event, an Earth Day Cleanup in partnership with the Anacostia Watershed Society.

With the farm bill deadline looming and the IRA funds flowing, Lindahl also made a point to expand beyond existing partners in conservation, meeting with congressional leadership.

Lindahl, along with SWCS members, was able to amplify the needs of conservation professionals to meet the demands of new funding during discussions around Conservation Technical Assistance and Technical Service Providers. SWCS members were also able to bring forward science to support the effectiveness of conservation practices on climate change and alert DC of the topics that compel people locally to advance conservation.

While it was only two short months, Lindahl made the most of her time. She met with over 50 leaders in congress, federal agencies, local governments, nonprofit organizations, foundations, the private sector, and media. She strengthened existing relationships created during last year's visit and created new connections in the conservation community.

In June, Bennie Loyd joined the SWCS team for the summer. Bennie has been developing a program for conservation outreach in Baton Rouge, Lousiana, where he currently attends Southern University, majoring in plant and soil science. He weighed in on special projects, including A Conservation Professionals' Guide to Diversity, Equitable and Inclusive Conservation Delivery Among the Historically Underserved. He also assisted staff with improving the headquarters grounds and building ahead of the 78th SWCS International Annual

Conference. Additionally, Bennie attended and assisted staff at the conference earlier this month. We're sorry to see him go, but wish him well as he returns to school!

## Welcome New At-Large Director, **Leonard Jordan!**



Leonard Jordan has spent more than four decades building a portfolio focused on conserving our natural resources. Having worked across the nation, Jordan has worked with several interest groups, government agencies, and nonprofit organizations to ensure that our environment is

protected. His passion is to work with the American public, providing assistance that helps improve their lives and bring resilience to rural America.

As Acting Chief of the USDA's Natural Resources Conservation Service (NRCS), Jordan oversaw programs that preserve our natural resources and improve agricultural sustainability through voluntary, privatelands conservation. He led a staff of more than 10,000 employees across the United States.

Jordan served as NRCS' Associate Chief for Conservation 2013 to 2017 where he led the agency's conservation mission area, including all of NRCS' conservation programs.

Jordan served as Regional Conservationist for the East from 2009 to 2011 and Regional Conservationist for the Southeast from 2011 to 2012. This was after the agency split organization of the East region into Northeast and Southeast. In these positions, Jordan provided direction on NRCS programs and activities regionally.
