Science and Policy Committee Seeking Student Representative for 2023

The SWCS Science and Policy Committee is made up of members representing many conservation professions. They convene virtually each month to discuss new and emerging conservation research, listen to invited speakers, and advise SWCS leadership on policy matters. SWCS is seeking a student representative to join the committee. The student selected will serve from February to November of 2023, and will be expected to attend all monthly virtual meetings. They will also be encouraged to attend the SWCS annual conference in Des Moines, lowa, August 6-9, 2023; assist in student recruitment activities; and undertake a project under guidance from the committee related to their professional interests.

Science and Policy Update: December Meeting

The Science and Policy Committee serves the Soil and Water Conservation Society and its members by gathering information and knowledge about pertinent topics within conservation science and policy, making them accessible, and producing results-driven content and advice. It also provides policy experience to natural scientists, building career experiences in policy for early career scientists and students. The Society is actively engaged in policy focused on conservation. Previously, the committee developed Principles of Conservation (Manale et al. 2018).

At our recent meeting on December 8, SWCS CEO Clare Lindahl informed the committee of policy protocols in SWCS. With support from the Society, Clare was able to spend three months in Washington, DC, this past year, making many important connections, developing meaningful contact with 69 different agencies and organizations, and recruiting new members. She noted that through the opportunity to be in DC, she felt more connected to other national leaders, since conservation is about relationships, and building these relationships is important to the mission of the Society.

Clare shared some important lessons learned from her time in DC. The Society has a unique perspective. As Clare stressed, if we are not at the table, what won't be said? What won't be heard? The voice of conservation professionals, agriculture, and our unique perspective on science-to-practice are critical values that Society members bring. While most of us do not work in policy (and are indeed often prohibited as state and federal government employees from having anything to do with policy), there are policy implications of all of our work. Our voices, experiences, knowledge, and insights are needed to guide policy.

The work of SWCS staff is to build coalitions. SWCS is now part of the Ag Conservation Coalition. We have a presence in Washington, DC. The Society plans to do more policy-related work, rearrange or reassign staff, and add staff or consultants as needed to better serve the Society and be the voice for conservation. The Society is in the process of developing a policy on policy that aligns with the needs and interests of our members and identifies actions. The recent survey of Society members revealed that the primary interest was to be informed of relevant policy and trends. Clare will be having meetings on the Farm Bill, and will keep the Science and Policy Committee informed of what science is needed. Clare closed her presentation with a reminder that advocacy is a process, not an event. It requires building relationships.

The broad expertise in basic and applied science of conservation within the Society membership gives us a unique potential to inform policy based on solid scientific principles. The SWCS staff and Science and Policy Committee will be working to organize a framework to identify critical issues; develop roundtables, listening sessions, and dialogues to explore these issues; and prepare information for dissemination. The committee meets on the second Thursday of every month at 3 p.m. CT; all Society members are welcome. This year, we have sought to identify and address key issues of importance in which science can direct policy. Some key issues that have been identified to date include carbon markets and fertilizer management. With the rewrite of the Farm Bill in 2023, the committee will also be exploring critical topics related to conservation for the Farm Bill. The Science and Policy Committee will be publishing monthly reviews of our meetings in the Conservogram to inform Society members of our progress and work.
