
Submission deadline for individual awards and scholarships is April 24, 2020.

#### Journal of Soil and Water **Conservation** News

#### March/April Issue of the Journal



The March/April issue of the *Journal of Soil and Water* Conservation is available online and will be arriving in mailboxes soon. This issue's A Section includes a unique viewpoint article by **Hargrove** et al. regarding underutilized conservation-based methods for providing access to clean water in isolated rural communities. In addition, a feature by Olson and Tharp explores the

history of the Passaic River and its contamination due to Agent Orange manufacture during the mid-twentieth century. Efforts to recover the river, now an Environmental Protection Agency Superfund site, continue today.

Research in this issue addresses many topics, including impacts of a drip irrigated conservation agriculture system in sub-Saharan Africa, effects of forest burning on soil properties in subtropical China, and soil health results of integrating cover crops, no-till, and terraces in Missouri corn and soybean agriculture. Additionally, an article by Poudel et al. takes a comprehensive approach to water quality in a Louisiana watershed by examining relationships between physiochemical and biological properties over time. Find these and many more articles in the online journal.
