## **Special Journal Issue: Climate Change Impacts on Soil and Water Conservation**



The March/April issue of the Journal of Soil and Water Conservation (ISWC) is a special collection of work that serves to synthesize our knowledge of the state of soil and water conservation and advance understanding of the soil-water-climate system, emerging technologies, and climate change adaptation and mitigation policies and practices to foster resilient agricultural and forest

systems that can support the people dependent on them.

For an overview of the research presented, be sure to read the introductory article written by the special issue organizers, Jean Steiner, Xiaomao Lin, Nancy Cavallaro, Georgia Basso, and Gretchen Sassenrath. Also in the A Section, features include an argument for regenerative agriculture to address climate change, a summary of US policy on climate change and environmental justice, and a review of <u>climate-pest interactions</u> and conservation management. Two viewpoint articles provide perspectives on research progress and the international implications of climate change. In the Research Section, articles cover diverse topics, including climate resilience of <u>rangelands</u>, cropping systems that minimize <u>nitrate leaching</u> under precipitation, perennial crops, soil organic carbon storage, and <u>a framework</u> for estimating potential greenhouse gas emission reductions from conservation adoption.

## **Highlights of the Student Professional Development Series**

SWCS partnered with MANRRS and the Soil Health **Institute** to put together a webinar series for students and early career professionals looking to enter the conservation field. The goal of this webinar series is to provide professionals with ongoing and accessible development training to prepare them for positions of leadership and ultimately increase the diversity of leadership in agriculture and natural resource conservation and applied sciences. This four-part series covers finding the career for you, financial literacy, thriving at work and school, and personal branding.

Below are some of the major takeaways from each session.

Finding the Career for You—Ms. Beatrice Faulkner and Dr. LaKisha Odom

- Don't worry about what you don't have, such as years of experience or a certain skill set. Focus on what you do bring to the table. The other skills can be learned and developed over time.
- Establish and embrace your unique "secret sauce" that makes you a valuable asset to the organization. Present your value with confidence.
- You are not static in your skill set. You will learn and amass new skills throughout your career, so don't shy away from positions that have tasks you are unfamiliar with.
- Manage your energy, not your time. If you gauge your productivity on the amount of time you work, the quality of your work will eventually suffer.

#### Financial Literacy—Ms. Penny Gomez

- People fail at their finances due to a lack of education, planning, and/or guidance.
- You can start an investment account with as little as \$25. You don't have to have a lot of money to start investing-just start! The longer you wait, the less you will accumulate.
- As you begin to plan out your finances, you need to set up three essential accounts: Emergency, Shortterm, and Wealth Building.

#### Thriving at Work and School—Dr. Fátima Sancheznieto

- Career trajectories are messy and rarely linear, so it is important to have a mentor to guide and support you through the twists and turns.
- Mentorship takes work and commitment from both the mentor and the mentee. The relationship should be mutually beneficial and provide both career and psychosocial support.

It is good to establish multiple formal and informal mentors that can advise on different aspects of your career and life. The most important aspect is to be clear about the type of support you seek when approaching a new potential mentor.

#### Branding U—Ms. Yai Vargas

- Develop your unique value proposition and share it with people. Don't assume people know your value based on your degree or certification. Many people have the same credentials, but no one has the exact same accomplishments, experience, and skill set.
- "Add to the culture, don't fit into the culture."
- Ensure you are consistent with who you are and what interests you across all social media profiles and posts. This will help you establish an easily recognizable, authentic brand.
- "People do not care about your fancy title. They care about what you do, how you do it, and what impact you have."

## **Science and Policy Committee Update: February Meeting**


