2019 SWCS Annual Workshop – Tragic Fire Ecosystem – 2018 Spring Creek Fire

In October 2019, the SWCS hosted a one-day workshop on the effects that fire disturbance has on forest and rangeland ecosystems as well as ecosystem recovery. The workshop was held in La Veta and included presentations, a panel discussion and tours of two areas affected by the 2018 Spring Creek Fire.

The mayor of La Veta, Doug Brgoch, opened the workshop with background on the Spring Creek Fire and its impact on the La Veta community. The workshop included speakers with various backgrounds on the effects that fire has on watersheds, flooding, erosion, insect community and plant recovery. Paul Branson, (Wildfire Preparedness Coordinator, La Veta), Tony Arnold (District Conservationist, NRCS, Walsenburg) and Manuel Molles (La Veta Landowner and retired Ecosystem Ecologist, University of New Mexico) volunteered to serve on the panel and provided insight to areas affected by the Spring Creek Fire. The panel discussion included pre-fire planning, fire mitigation and response network, availability of government assistant programs and post fire recovery. Steve Keppers conducted a tour on the wildfire mitigation and recovery activities at Tres Valles West area where approximately 800 acres was burned. Tony Arnold led the second tour which occurred at the Paradise Acres Subdivision. Several thousand acres burned within the subdivision and around 20 homes were lost. Approximately 20 non-members and eight SWCS members attended the annual workshop where we also provided morning refreshments and lunch. The <u>Colorado Post-Fire Recovery Playbook</u> is now available as a practical worksheet and guide to assist municipalities, counties, tribes, and water providers in post-fire rehabilitation. This useable Playbook includes:

- 12 specific steps these entities can take before, during, and within the first 30-days of a wildfire to facilitate post-fire rehabilitation,
- a fillable list of critical contacts, allowing users to know exactly who to contact and when, and graphics that clearly communicate roles and responsibilities and key funding sources.



Junior Conservationist of the Year

The 2019 SWCS Junior Conservationist of the Year was awarded to Josh Waller. Josh was a Senior at Hoehne High School and was very active in his Ag classes and FFA. Josh placed 1st at the SE CO Regional Districts FFA Range Judging event in September of 2019 and was awarded 2nd highest individual score at the state FFA range judging in Fall 2019. Josh also participated in the SRM High School Youth Forum in Minneapolis, MN as one of the delegates to the forum representing the CO Section of the SRM.

Conservationist of the Year

The 2019 SWCS Conservationist of the year was awarded to Pattie Becker of the Fletcher/Becker Ranch located near Agate. Pattie operates 754 acres that has been in her family since 1923 when her grandparents, Joel and Eva Fletcher arrived in Elbert county. Mr. and Mrs. Fletcher grew beans, corn, oats and wheat and after the flood in 1965 they became supportive of the flood control dams, diversions, terraces and grass seeding which were supported by the Agriculture Conservation Program.

Pattie's father, Jack Fletcher worked the ranch raising wheat, barley and cattle with his wife Ruth both of whom were selected as the Agate Conservationists of the Year in 1989. Pattie grew up on the ranch and learned about conservation from her grandparents and parents who implemented conservation practices including diversions, terraces, dams, wells, fencing and woodland harvesting. Pattie and her late husband Dick began farming the ranch in 1972. Pattie and Dick built flood control dams, numerous stockwater dams, diversions and terraces for erosion control as well as a grass seeding project.

Pattie has entered into CSP contracts to add more practices to her conservation plan. In 2012 she added a living snow fence and 200 Rocky Mountain Junipers. She also installed a windbreak planting with more than 630 trees planted. The results of her conservation efforts have promoted abundant wildlife on her land including ducks, turkeys, mule deer and mountain lion. Some of her current conservation plan practices include on farm forage based grazing system, the utilization of bird ladders in all tanks, monitoring the nutritional status of ruminant livestock using NUTBAL system, windbreaks, and monitoring key grazing areas to improve grazing management.

Pattie's past and current conservation practices, as well as her involvement with 4-H, Elbert/Douglas Livestock Association, Farm Bureau and the Elbert County Cattlewoman has awarded her the 2019 Colorado SWCS Conservationist of the Year Award.



The Chapter did not have a College Scholarship recipient for 2019. Each year we have two \$500 scholarships available to a Junior or Senior attending a Colorado college or university in a natural resource field. The Chapter also offers grants. If you see a need where a SWCS fund can help or encourage conservation, please contact us.

This year, 2020, our recipient is pending notification.

The 75th Annual Conference will be virtual this year, July 27-29, 2020 from Des Moines, Iowa

This year's conference theme, "Expanding Horizons: Where Conservation Meets Innovation," evokes images of the expansive views of the region and the deep and varied soil horizons that make lowa's farmland some of the most productive in the world. This year's theme also speaks to the broadening of individual perceptions and experiences as attendees discover new concepts, partners, and advancements in soil and water research.

The conference will feature the latest ideas, technologies, and practices and foster a dialogue around their adoption. Through virtual workshops, sessions, symposia, exhibits, and galleries, cutting-edge research and practice developments in soil health, water quality, and resource management will be shared. Scientists and practitioners will present their work at the field, farm, and watershed scale across an array of private and public arenas. Researchers and conservationists will team up with farmers to share lessons learned and the environmental outcomes of on-farm trials, monitoring, and state-of-the-art precision agricultural tools. Applications of social theories and examples of successful outreach and education will enable attendees to identify ways to scale up grassroots efforts. Participants will also hear about policy and economic developments that build a framework to increase conservation adoption and support future generations.

The Soil and Water Conservation Society's 75th International Annual Conference will assemble a diverse, multigenerational conservation community of researchers, practitioners, industry leaders, farmers, and students from around the world. Join us virtually as we recognize lessons from the past, expand our professional and personal horizons, and shape the future of conservation.
